- D. Updates on EPA and Govt. Shutdown:
 - i. Tribal Air Key Focus 2019 document presented by Pat Childers in preparation for future meetings.
 - ii. National Tribal Operations Committee (NTOC) rescheduled to April 10, 2019
 - iii. OAQPS Tribal consultation letters on MATS were sent out.
 - iv. Public hearing for NSPS revision for GHG emissions from new, modified, and reconstructed fossil fuel-fired power plants on Thursday, February 14, 2019. One request for consultation from a Tribe.

2. NTAA PARTNERSHIP UPDATES:

- A. Tribal Air Monitoring Support (TAMS) Center: TAMS center employees will work from home if government shuts down. Camille Quickbear is new chair. New open seat on Steering committee.
- B. National Tribal Caucus (NTC): No updates
- C. Clean Air Act Advisory Committee (CAAAC): Open seat. Current members also need to reapply for next 2 years. Application for open seat opportunity, due March 15.
- D. ITEP: VW Settlement Technical Assistance Program: March 18 deadline for new Tribes to apply for 2nd round of funding. About 10 Tribes have applied for 2nd round so far. 1st round opt in automatically unless they opt out. Program will be posting announcement for nominations for Tribal Advisory Council.
- E. National Radon Action Plan: Next call is March 6, 2019.
- F. Association of Air Pollution Control Agencies (AAPCA) and National Association of Clean Air Agencies (NACAA): AAPCA informed us of congressional subcommittee hearing on appropriations for Tribal programs.
 NACAA will meet with NTAA on Tuesday March 12 in afternoon in Washington, D.C.
