

National Tribal Air Association's Fact Sheet on CEQ's Draft National Environmental Policy Act Guidance on Consideration of Greenhouse Gas Emissions

What are the proposed changes to the Guidance on Consideration of Greenhouse Gas Emissions?

The White House Council on Environmental Quality (CEQ) issued a new Draft Guidance on the Consideration of Climate Change in National Environmental Policy Act (NEPA) Reviews.¹ The Draft Guidance would replace the 2016 final Guidance² issued on August 1, 2016, by the Obama administration, which was withdrawn by the Trump Administration CEQ for further consideration under Executive Order 13783.³ The purpose of the Draft Guidance is to assist Federal agencies in their consideration of greenhouse gas (GHG) emissions and climate change when evaluating proposed Federal actions in accordance with NEPA and the CEQ Regulations Implementing the Procedural Provisions of NEPA⁴ (CEQ Regulations) as well as facilitate compliance with NEPA by Federal agencies conducting reviews of proposed major actions.

What Does this Mean for Tribes and Air Quality/Air Management?

The NTAA has several concerns regarding the new Draft Guidance. By allowing agencies to avoid fully quantifying emissions for projects or analyzing the cumulative effects of emissions, this proposal would limit the scope of emissions considered under NEPA and undercut the standard that agencies have been using to estimate GHG emissions for nearly a decade. While the new Draft Guidance acknowledges that GHG emissions have environmental impacts and that these direct and indirect emissions should be quantified, the Draft Guidance limits the scope of the required analysis and does not require agencies to disclose the monetized social costs of GHG impacts. Also, the Draft Guidance does not set forth tools agencies can use in calculating both direct and indirect emissions from a project, nor does it require consideration of alternatives or potential mitigation measures to reduce GHG emissions.
